





Total Assets







Operating income – Segment wise





It consists of 7 screens having seating capacity of 1,146. It is located at Al Liwan mixed-use project in Hamala in the Northern Governorate.
- ☐ The Company has appointed Mr. Ahmed Abdulgaffar as the Assistant Chief Executive Officer w.e.f. 2nd April, 2023.
- ☐ Entry of new competitors in the market
 Cinepolis opened in July 2022 in Amwaj Island have 5 screens and EPIX Cinema opened in May 2023 in Dana Mall having 10 screens.
